02 INFORMATION ABOUT THE DOG OWNER'S INSURANCE COMPANY

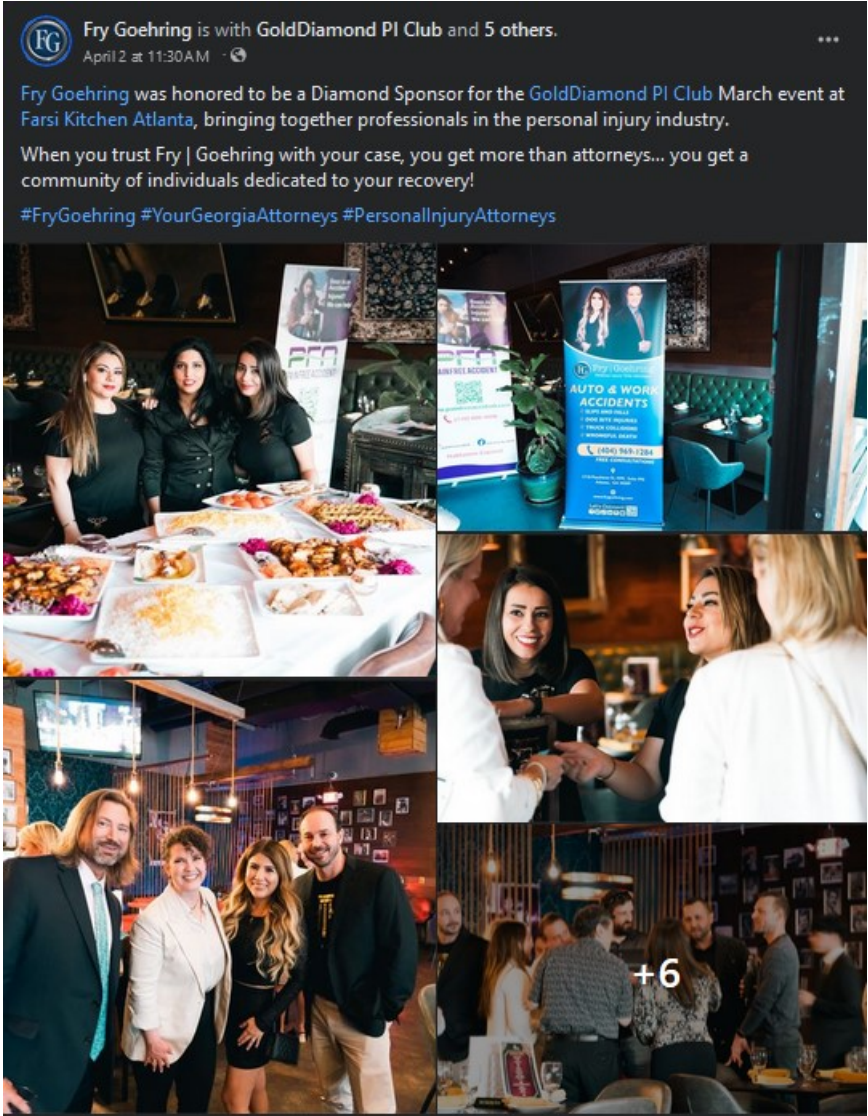
03 THE DOG'S RECORD OF VACCINATIONS
